### Transmission Outages

The above outage table is produced using the best available information as submitted to the AESO by market participants. All Alberta loads greater than 40 MW are required to provide outage information as set out in the MSA Trading Practices Guideline. The table presented in this report is prepared by aggregating submitted outage information.
