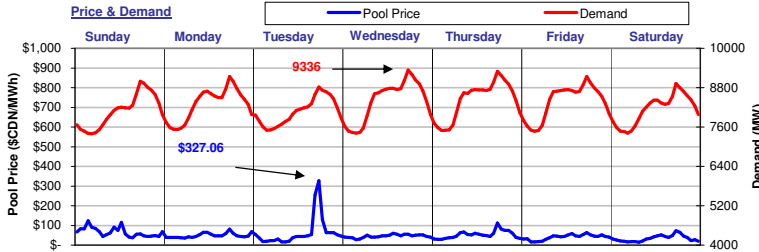

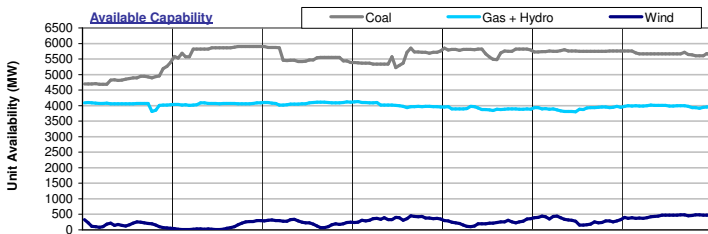

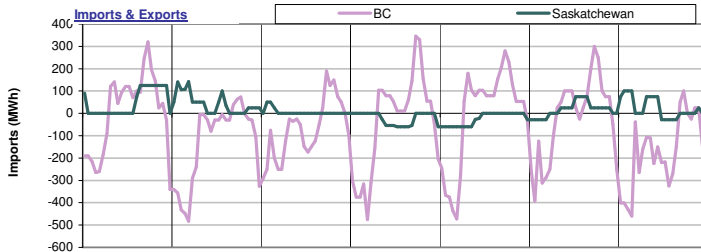
Weekly Highlights



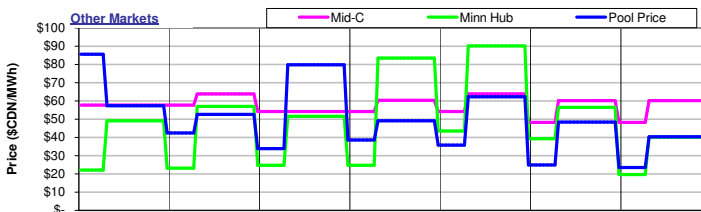
For the week ending January 5, 2007, **Pool Price** averaged \$50.32/MWh and ranged from a minimum of \$15.22/MWh in HE08 on Saturday to a maximum of \$327.06/MWh in HE18 on Tuesday. **Demand** reached a high of 9336 MW in HE18 on Wednesday and a low of 7397 MW in HE05 on Sunday. Average demand for the week was 8254 MW. **Pool Price** and **Demand** were positively correlated last week with an R-squared value of 0.10.



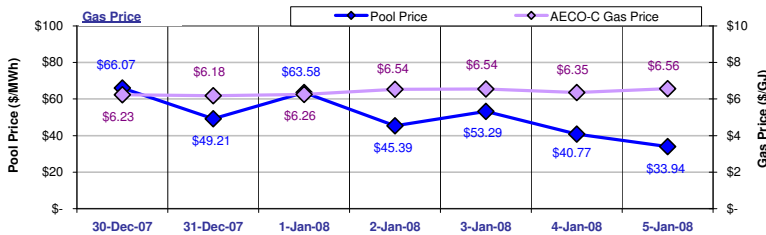
Coal Unit Availability averaged 5563 MW last week. This is an equivalent availability of 93%. **Gas, Hydro and Other Unit Availability** averaged 4001 MW last week, which is an equivalent of 82%. **Wind Generation** averaged 261 MW last week. This is an equivalent availability of 52%. Availability numbers are based on MW offered into the energy merit order.



Alberta was a net exporter to BC last week with total exports equal to 10,530MWh. Alberta was a net importer from Saskatchewan last week with total imports equal to 2,128 MWh. Overall, Alberta exported 8,402MWh of electricity last week.



Pool Prices were generally lower than prices in **Mid-C** and higher than prices in **Minn Hub** last week. **Mid-C** prices averaged \$60.47/MWh on-peak and \$53.53/MWh off-peak. **Minn Hub** prices averaged \$63.13/MWh on-peak and \$28.16/MWh off-peak. Prices in \$/MWh at an exchange rate of 0.98196.



The average **AECO-C Gas Price** last week was \$6.38/GJ and ranged from a minimum of \$6.18/GJ to \$6.56/GJ. Prevailing gas prices resulted in market heat rates ranging from a low of 5.17 GJ/MWh to a high of 10.60 GJ/MWh. The average market heat rate for the week was 7.91 GJ/MWh.

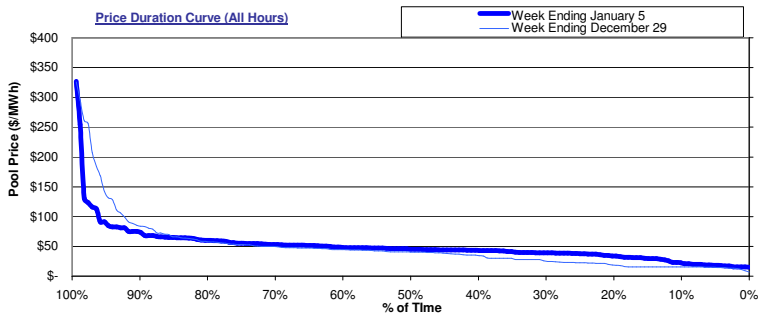

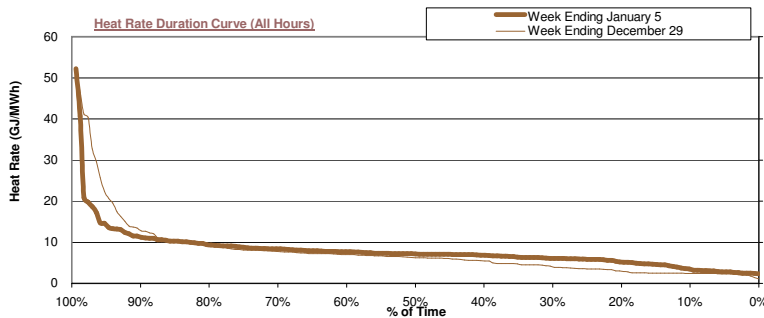

The price duration curves show the % of time that prices were at or below a certain value during the week. For the week ending **January 5**, prices were at or below:

- \$20/MWh 8% of the time
- \$50/MWh 61% of the time
- \$100/MWh 96% of the time
- \$250/MWh 98% of the time
- \$500/MWh 100% of the time



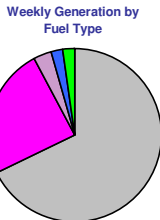
The heat rate duration curves show the % of time that the implied market heat rate was at or below a certain value during the week. For the week ending **January 5** implied market heat rates were at or below:

- 5.0 GJ/MWh 18% of the time
- 10.0 GJ/MWh 83% of the time
- 15.0 GJ/MWh 96% of the time
- 20.0 GJ/MWh 98% of the time

Legend: Coal (Grey), Gas - Cogen (Pink), Gas - Other (Light Blue), Hydro (Dark Blue), Other (Green)



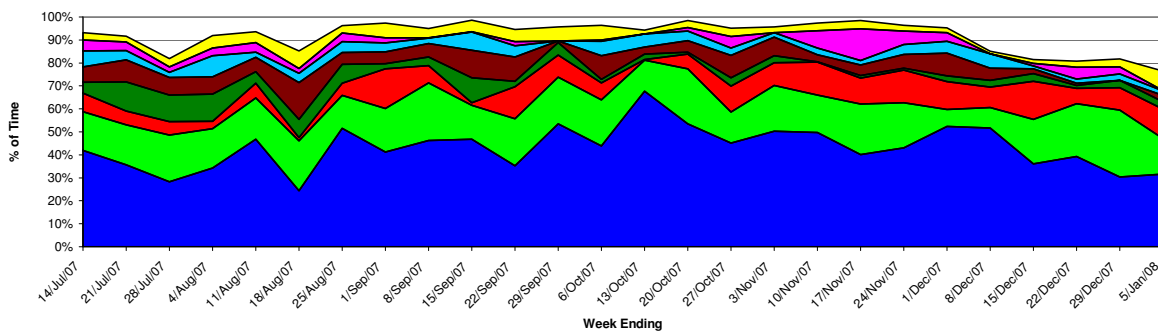

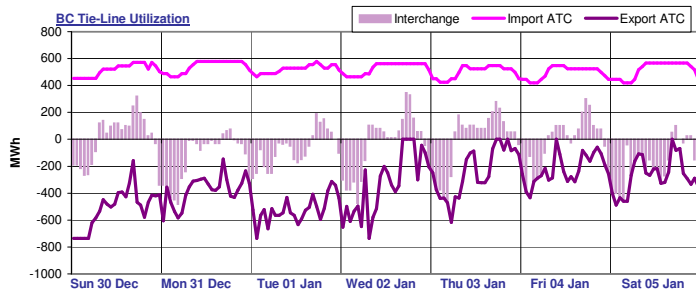
Last week, **coal units** were responsible for **67.9%** of the generation in the province and set price **59.4%** of the time. **Gas-cogen** units accounted for **24.4%** of the generation and set price **34.7%** of the time last week while **other gas** units made up **3.2%** of generation and set price **5.3%** of the time.

A total of **15** market participants set price last week. **One** market participants set price more than 20% of the time last week. The top price setter set price **31.6%** of the time and the top five price setters set price a total of **81.6%** of the time.

Weekly Price Setting by Submitting Customer

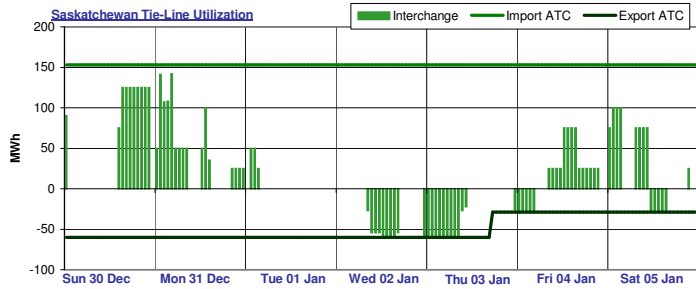


Interties

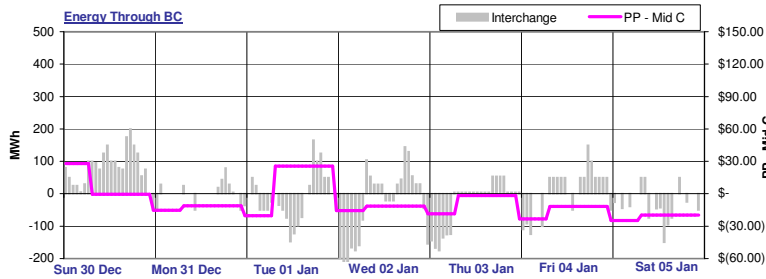


BC import capacity was 12% utilized last week while BC export capacity was 36% utilized. Energy was being imported into Alberta over the BC tie-line 44% of the time and exported out of Alberta over the BC tie-line 55% of the time last week. There was no activity on the BC tie-line 1% of the time last week.

Note: External reserve contract volumes have been subtracted from the BC import ATC as this capacity is not available to import energy into Alberta.



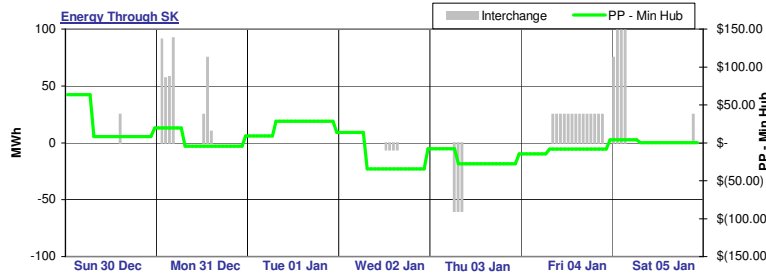
Saskatchewan import capacity was 14% utilized last week while Saskatchewan export capacity was 18% utilized. Energy was being imported into Alberta over the Saskatchewan tie-line 31% of the time and exported out of Alberta over the Saskatchewan tie-line 19% of the time last week. There was no activity on the Saskatchewan tie-line 50% of the time last week.



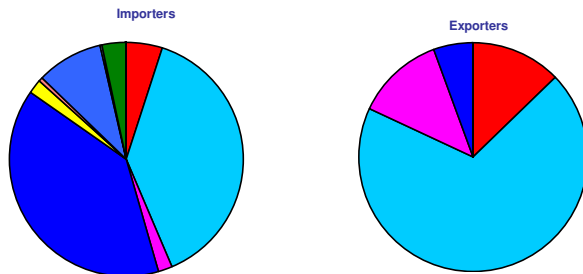
Last week, Alberta spot prices were mostly lower relative to prices in the Pacific Northwest as represented by Mid-C index prices, supporting export activity across the Alberta - BC interconnection.

Alberta prices were generally higher than prices in MAPP as represented by spot prices at the Minnesota Hub, which generally supports import activity across the Alberta - Saskatchewan interconnection.

Note: Platt's day-ahead strip prices used in energy through BC and SK graphs.



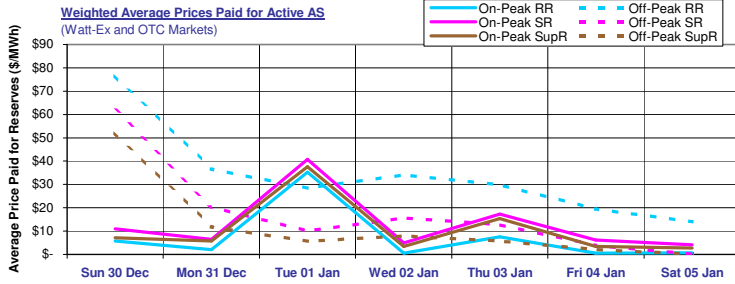
Tie-Line Market Shares



Last week, there were a total of 9 importers. The most active importer had a market share of 39.0% while the second most active importer had a market share of 38.6%. There were a total of 4 exporters last week. The most active exporter had a market share of 69.1% while the next largest exporter had a market share of 12.7%.

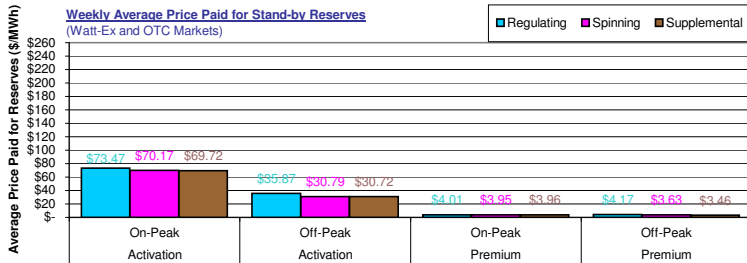
Note: Market shares are based on the combined activity on both interties.

Ancillary Services Market



Average on-peak prices paid for active ancillary services last week were **\$7.53/MWh**, **\$12.87/MWh** and **\$10.44/MWh** respectively for active **regulating**, **spinning** and **supplemental** reserves.

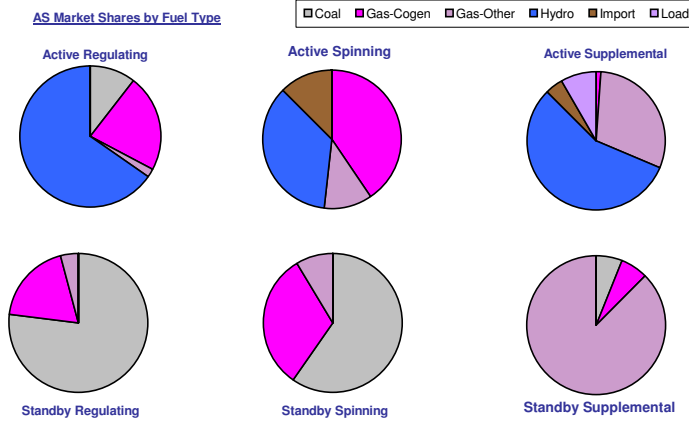
Active average off-peak prices were **higher** and averaged **\$34.12/MWh**, **\$17.58/MWh** and **\$12.18/MWh** for active **regulating**, **spinning** and **supplemental** reserves respectively.



Weekly average activation prices for stand-by reserves ranged from **\$30.72/MWh** for **off-peak supplemental** reserves to **\$73.47/MWh** for **on-peak regulating** reserves.

Weekly average premium prices ranged from **\$3.46/MWh** for **off-peak supplemental** reserves up to **\$4.17/MWh** for **on-peak spinning** reserves.

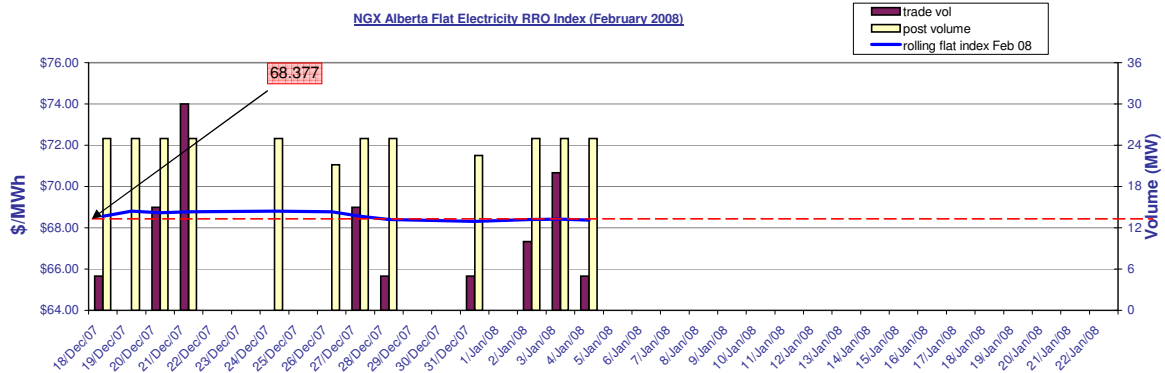
AS Market Shares by Fuel Type



Last week **hydro** units had the largest market share in the **active regulating** reserve market with **65.4%**. In the **active spinning** reserve market, **gas-cogen** units had the leading market share with **40.5%** while in the **active supplemental** reserve market, **hydro** units dominated with a **56.2%** market share.

Coal units dominated the **standby regulating** reserve market with a **76.8%** market share. Leading market share in the **standby spinning** market was held by **coal** units with a **59.7%** market share. In the **standby supplemental** reserve market, **gas** units had the leading market share with **87.4%**.

Glossary

- On-Peak Hours**
In Alberta: HE08 through HE23, Monday through Saturday (prevailing Mountain time)
In Mid-C: HE07 through HE22, Monday through Saturday (prevailing Pacific time)
In Minn Hub: HE08 through HE23, Monday through Sunday (prevailing Central time)
- Off-Peak Hours**
In Alberta: HE01 through HE07 + HE24 (of the same day), Monday through Saturday + HE01 through HE24 Sundays + holidays (prevailing Mountain time)
In Mid-C: HE24 (of the previous day) through HE07 (of the day in question), Monday through Saturday + HE01 through HE24 Sundays + holidays (prevailing Pacific time)
In Minn Hub: HE24 (of the previous day) through HE07 (of the day in question), Monday through Sunday (prevailing Central time)
- ATC**
A measure of the maximum energy flow possible in one direction across an intertie.
- Market Heat Rate**
The prevailing Pool price divided by the prevailing gas price.
- Sparks spread**
Sparks spreads give an indication of the revenue available to cover costs after fuel costs have been paid. A positive spread indicates it is more economical to buy gas and generate electricity while a negative spread indicates it is more economical to buy electricity from the grid.
