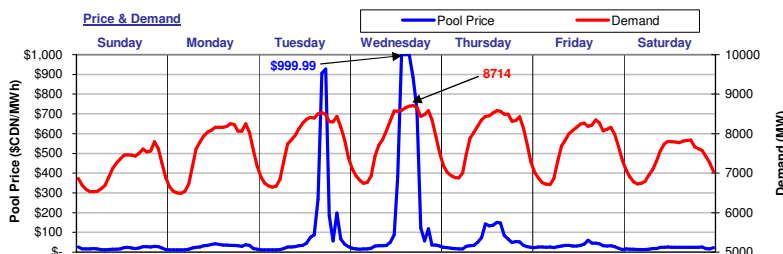

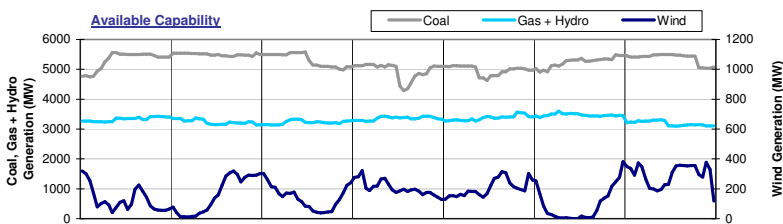

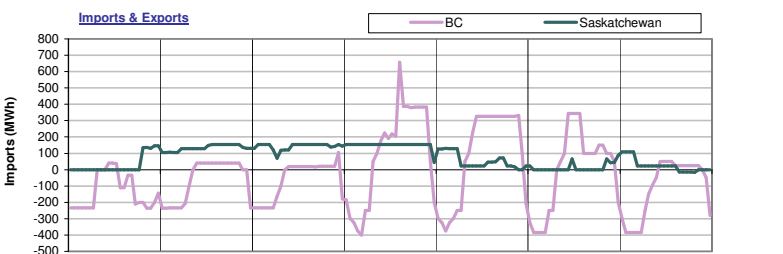
Weekly Highlights



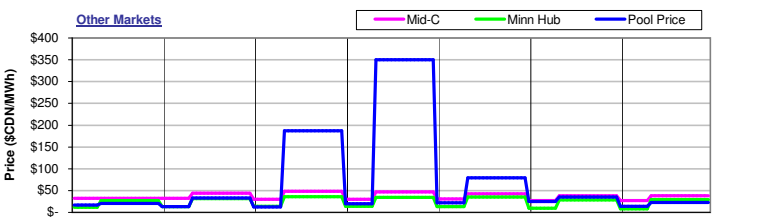
For the week ending September 26, 2009, **Pool Price** averaged \$75.32/MWh and ranged from a minimum of \$10.59/MWh in HE08 on Sunday to a maximum of \$999.99/MWh in HE15 on Wednesday. **Demand** reached a high of 8714 MW in HE17 on Wednesday and a low of 6489 MW in HE04 on Monday. Average demand for the week was 7633 MW. **Pool Price** and **Demand** were positively correlated last week with an R-squared value of 0.19.



Coal Unit Availability averaged 5236 MW last week. This is an equivalent availability of 87%. **Gas, Hydro and Other Unit Availability** averaged 3312 MW last week, which is an equivalent of 61%. **Wind Generation** averaged 175 MW last week. This is an equivalent availability of 31%. Availability numbers are based on MW offered into the energy merit order.

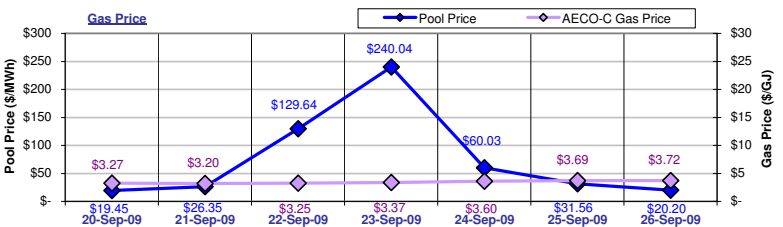


Alberta was a net exporter to BC last week with total imports equal to 4,646 MWh. Alberta was a net importer from Saskatchewan last week with total imports equal to 13,083 MWh. Overall, Alberta imported 8,437 MWh of electricity last week.



Pool Prices were generally higher than prices in **Mid-C** and higher than prices in **Minn Hub** last week. **Mid-C** prices averaged \$42.95/MWh on-peak and \$30.10/MWh off-peak. **Minn Hub** prices averaged \$32.58/MWh on-peak and \$12.10/MWh off-peak.

The average **AECO-C Gas Price** last week was \$3.44 GJ and ranged from a minimum of \$3.20/GJ to \$3.72/GJ. Prevailing gas prices resulted in market heat rates ranging from a low of 5.43 GJ/MWh to a high of 71.18 GJ/MWh. The average market heat rate for the week was 22.27 GJ/MWh.

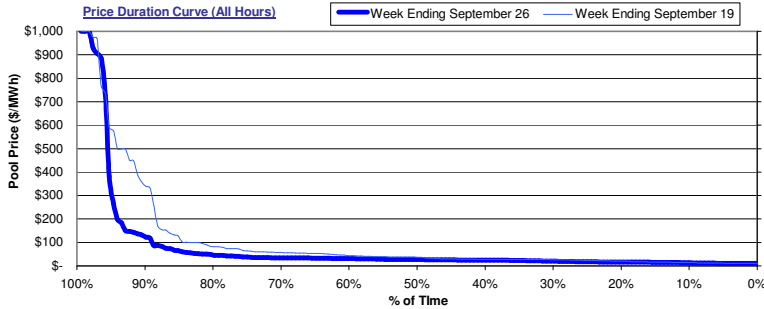

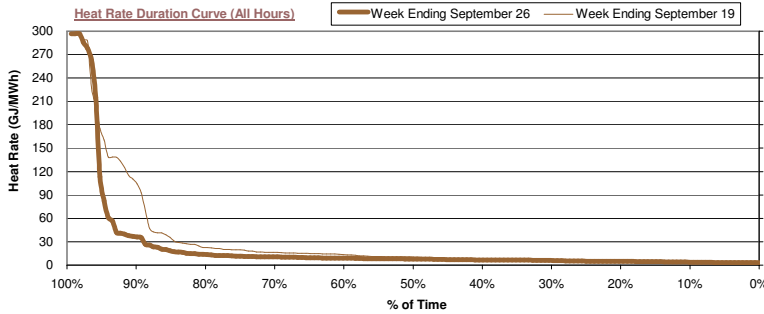

The price duration curves show the % of time that prices were at or below a certain value during the week.

For the week ending **September 26**, prices were at or below:

- \$20/MWh 95% of the time
- \$50/MWh 80% of the time
- \$100/MWh 60% of the time
- \$250/MWh 30% of the time



The heat rate duration curves show the % of time that the implied market heat rate was at or below a certain value during the week.

For the week ending **September 26** implied market heat rates were at or below:

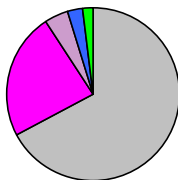
- 5.0 GJ/MWh 86% of the time
- 10.0 GJ/MWh 67% of the time
- 15.0 GJ/MWh 42% of the time
- 20.0 GJ/MWh 24% of the time

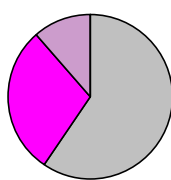

Weekly Generation by Fuel Type

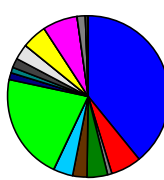


Weekly Price Setting by Fuel Type

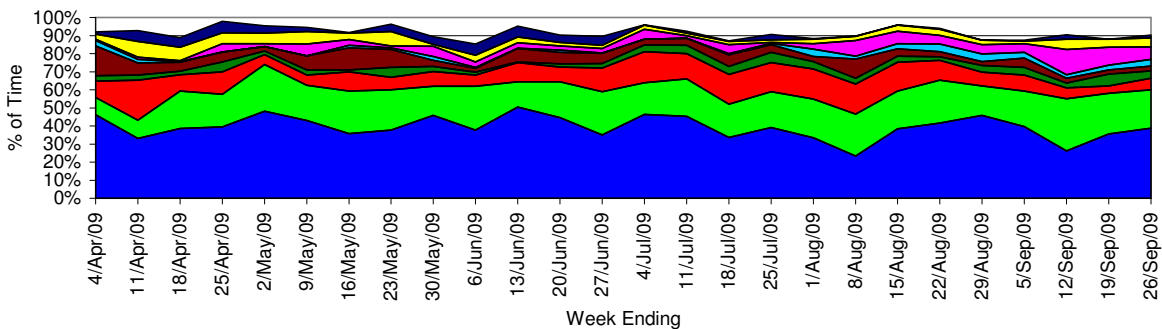

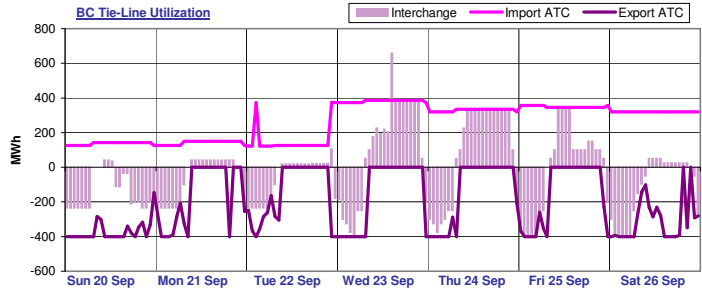
Last week, **coal units** were responsible for **67.2%** of the generation in the province and set price **58.9%** of the time. **Gas-cogen** units accounted for **23.8%** of the generation and set price **28.8%** of the time last week while **other gas** units made up **4.2%** of generation and set price **11.3%** of the time.

A total of **15** market participants set price last week. **Two** market participants set price more than **20%** of the time last week. The top price setter set price **38.8%** of the time and the top five price setters set price a total of **78.1%** of the time.

Weekly Price Setting by Submitting Customer

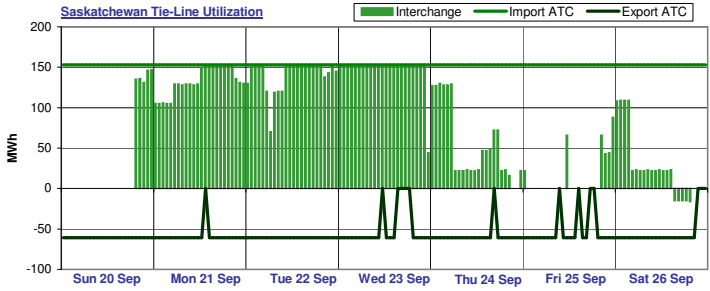


Interties

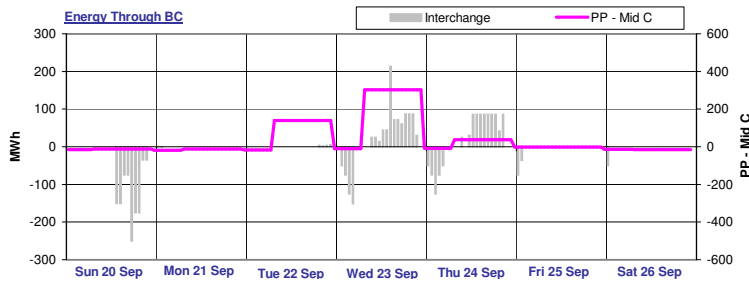


BC import capacity was 25% utilized last week while BC export capacity was 53% utilized. Energy was being imported into Alberta over the BC tie-line 52% of the time and exported out of Alberta over the BC tie-line 43% of the time last week. There was no activity on the BC tie-line 5% of the time last week.

Note: External reserve contract volumes have been subtracted from the BC import ATC as this capacity is not available to import energy into Alberta.



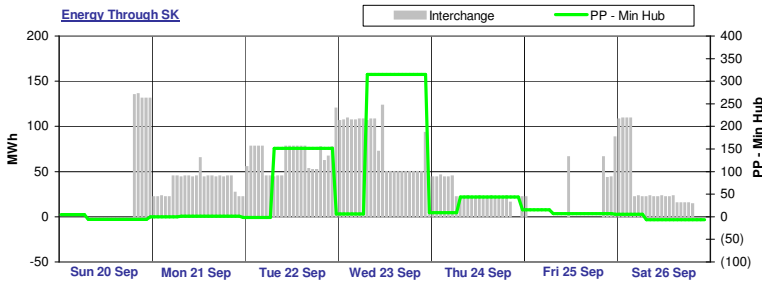
Saskatchewan import capacity was 51% utilized last week while Saskatchewan export capacity was 2% utilized. Energy was being imported into Alberta over the Saskatchewan tie-line 71% of the time and exported out of Alberta over the Saskatchewan tie-line 3% of the time last week. There was no activity on the Saskatchewan tie-line 26% of the time last week.



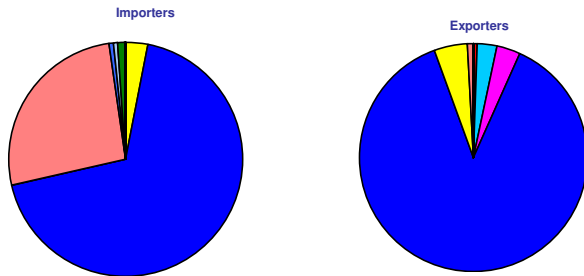
Last week, Alberta spot prices were mostly higher relative to prices in the Pacific Northwest as represented by Mid-C index prices, supporting import activity across the Alberta - BC interconnection.

Alberta prices were generally higher than prices in MAPP as represented by spot prices at the Minnesota Hub, which generally supports import activity across the Alberta - Saskatchewan interconnection.

Note: Platt's day-ahead strip prices used in energy through BC and SK graphs.



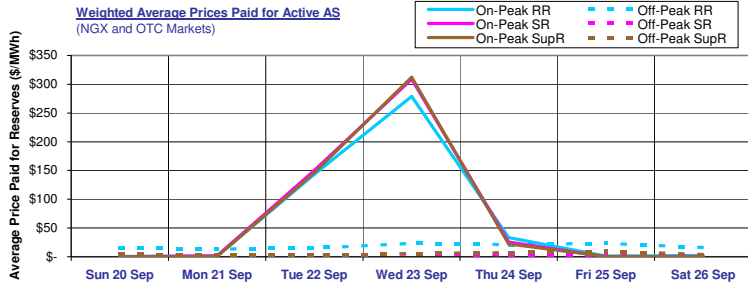
Tie-Line Market Shares



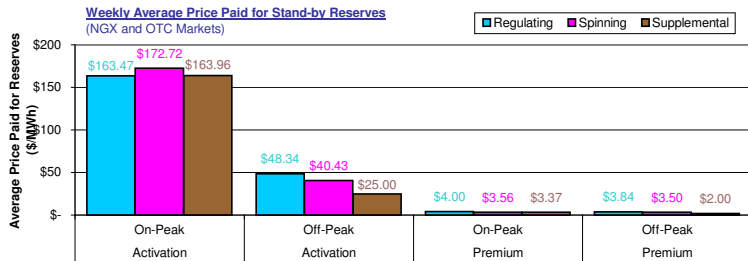
Last week, there were a total of 8 importers. The most active importer had a market share of 68.3% while the second most active importer had a market share of 26.2%. There were a total of 6 exporters last week. The most active exporter had a market share of 87.7% while the next largest exporter had a market share of 4.7%.

Note: Market shares are based on the combined activity on both interties.

Ancillary Services Market

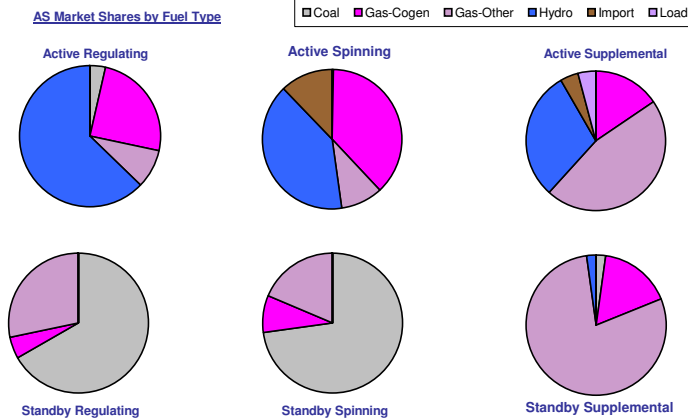


Average on-peak prices paid for active ancillary services last week were **\$67.84/MWh**, **\$72.02/MWh** and **\$70.02/MWh** respectively for active **regulating**, **spinning** and **supplemental** reserves.
Active average off-peak prices were **higher** and averaged **\$18.26/MWh**, **\$3.09/MWh** and **\$5.21/MWh** for active **regulating**, **spinning** and **supplemental** reserves respectively.



Weekly average activation prices for stand-by reserves ranged from **\$25.00/MWh** for **off-peak supplemental** reserves to **\$172.72/MWh** for **on-peak spinning** reserves.
Weekly average premium prices ranged from **\$2.00/MWh** for **off-peak supplemental** reserves up to **\$4.00/MWh** for **on-peak regulating** reserves.

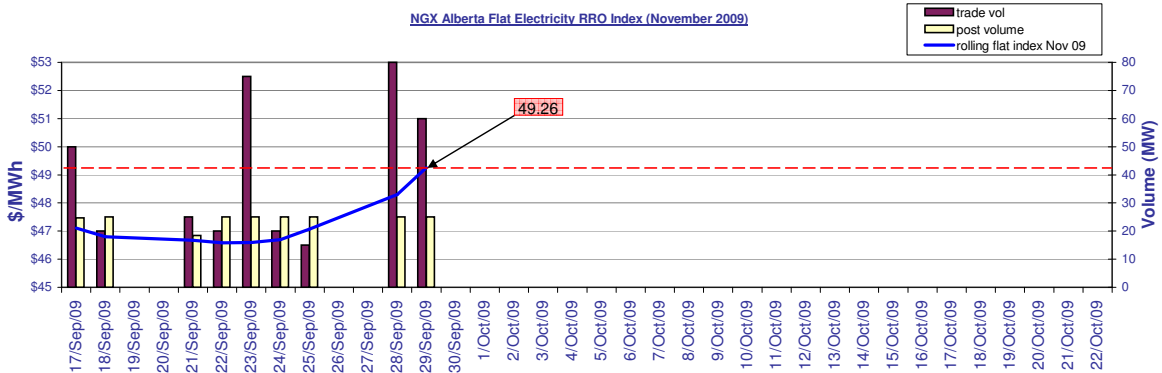
AS Market Shares by Fuel Type



Last week **hydro** units had the largest market share in the **active regulating** reserve market with **62.8%**. In the **active spinning** reserve market, **hydro** units had the leading market share with **40.0%** while in the **active supplemental** reserve market, **gas** units dominated with a **45.9%** market share.

Coal units dominated the **standby regulating** reserve market with a **66.6%** market share. Leading market share in the **standby spinning** market was held by **coal** units with a **72.7%** market share. In the **standby supplemental** reserve market, **gas** units had the leading market share with **78.7%**.

Glossary

- On-Peak Hours**
In Alberta: HE08 through HE23, Monday through Saturday (prevailing Mountain time)
In Mid-C: HE07 through HE22, Monday through Saturday (prevailing Pacific time)
In Minn Hub: HE08 through HE23, Monday through Sunday (prevailing Central time)
- Off-Peak Hours**
In Alberta: HE01 through HE07 + HE24 (of the same day), Monday through Saturday + HE01 through HE24 Sundays (prevailing Mountain time)
In Mid-C: HE24 (of the previous day) through HE07 (of the day in question), Monday through Saturday + HE01 through HE24 Sundays + holidays (prevailing Pacific time)
In Minn Hub: HE24 (of the previous day) through HE07 (of the day in question), Monday through Sunday (prevailing Central time)
- ATC**
A measure of the maximum energy flow possible in one direction across an intertie.
- Market Heat Rate**
The prevailing Pool price divided by the prevailing gas price.
- Sparks spread**
Sparks spreads give an indication of the revenue available to cover costs after fuel costs have been paid. A positive spread indicates it is more economical to buy gas and generate electricity while a negative spread indicates it is more economical to buy electricity from the grid.
