However, the asset was generating above the directive limit throughout the directive until the end of the directive at 20:48. ISO rule 304.3 indicates that a non-exempt wind aggregated generating facility must comply with a wind power limit pro rata share directive no later than ten minutes after the ISO sent the signal. **FINDINGS** Based upon the information obtained by the MSA, the MSA is satisfied that the event was a contravention of ISO Rule 304.3.
