EVENT DETAILS

On April 22, 2016 at 07:30, a bid was submitted for asset CWXS to export 54 MW in hour ending (HE) 16 on April 22, 2016. The e-tag for this export transaction was curtailed to 0 MW at 14:31 however no MW restatement was submitted to revise the export bid accordingly for HE 16. Subsection 7(2) of ISO rule section 203.3 indicates that a pool participant that submits a bid must submit a MW restatement reducing the MW to represent the operating state of the sink asset, as soon as reasonably practicable, if the sink asset cannot comply with the current bid as a result of an acceptable operational reason.

FINDINGS

Based upon the information obtained by the MSA, the MSA is satisfied that the event was a contravention of ISO Rule 203.3.

MATERIAL FACTS

The material facts relied upon by the MSA include the following:

1. AESO energy bid and e-tag data for CWXS for April 22, 2016.
2. AESO information request issued to Canadian Wood Products Montreal Inc. dated July 19, 2016.
3. Canadian Wood Products Montreal Inc. response to the AESO information request dated August 2, 2016.
4. Referral from the AESO to the MSA dated August 8, 2016.

DELIVERY OF PAYMENT

NOTICE

The Market Surveillance Administrator (MSA) is granted the power and authority under s. 52 of the *Alberta Utilities Commission Act* to issue a Notice of Specified Penalty where the MSA is satisfied that a person has contravened an ISO rule. Specified penalties are set out in AUC Rule 019.

In accordance with the relevant enactments and rules, a dispute regarding the issuance of a Notice of Specified Penalty or failure to pay the specified penalty in accordance with this notice will result in a hearing or other proceeding before the AUC.

In accordance with s. 5(1) of AUC Rule 019 this Notice of Specified Penalty will be made public no earlier than receipt of confirmation of payment from the Commission and no later than 45 days after issuance. The MSA will, if applicable, also post on its website the link to any decision of the AUC respecting the specified penalty.
