EVENT DETAILS

On June 2, 2016 at 13:14 an available capability (AC) restatement was submitted for WWD1 decreasing the AC from 10 MW to 0 MW for June 16 and 17, 2016 with a stated reason of "Schedule Plant Outage". Information available to the MSA indicated that the need for this outage was known to West Fraser Mills Ltd. on April 21, 2016. ISO rule 306.5 indicates that a pool participant must submit to the ISO, by the first day of every month, information regarding outages that are planned to occur at any time within the next twenty-four months. In the event that the planned outage information is submitted less than three months prior to the start date of the outage, the pool participant must also submit the reasons that the information deviates from the information previously submitted.

FINDINGS

Based upon the information obtained by the MSA, the MSA is satisfied that the event was a contravention of ISO Rule 306.5.

MATERIAL FACTS

The material facts relied upon by the MSA include the following:

1. AESO available capability data for WWD1 from June 16, 2016 to June 17, 2016.
2. AESO information request issued to West Fraser Mills Ltd. dated September 21, 2016.
3. West Fraser Mills Ltd.'s response to the AESO information request dated October 4, 2016.
4. Referral from the AESO to the MSA dated October 13, 2016.

DELIVERY OF PAYMENT

NOTICE

The Market Surveillance Administrator (MSA) is granted the power and authority under s. 52 of the *Alberta Utilities Commission Act* to issue a Notice of Specified Penalty where the MSA is satisfied that a person has contravened an ISO rule. Specified penalties are set out in AUC Rule 019.

In accordance with the relevant enactments and rules, a dispute regarding the issuance of a Notice of Specified Penalty or failure to pay the specified penalty in accordance with this notice will result in a hearing or other proceeding before the AUC.

In accordance with s. 5(1) of AUC Rule 019 this Notice of Specified Penalty will be made public no earlier than receipt of confirmation of payment from the Commission and no later than 45 days after issuance. The MSA will, if applicable, also post on its website the link to any decision of the AUC respecting the specified penalty.
