EVENT DETAILS

From February 15, 2016 to November 14, 2016, operating reserve offers for generating asset BR3 were accepted by the ISO; however, the corresponding offer control information submitted was incorrect. ISO rule 201.3 indicates that a pool participant must submit offer control information for all offers or bids which the ISO accepts for operating reserve.

FINDINGS

Based upon the information obtained by the MSA, the MSA is satisfied that the event was a contravention of ISO Rule 201.3.

MATERIAL FACTS

The material facts relied upon by the MSA include the following:

1. AESO ancillary services offer control data for BR3 from February 15 to November 14, 2016.
2. Self-report from Alberta Power (2000) Ltd. to the MSA dated December 23, 2016.

DELIVERY OF PAYMENT

NOTICE

The Market Surveillance Administrator (MSA) is granted the power and authority under s. 52 of the *Alberta Utilities Commission Act* to issue a Notice of Specified Penalty where the MSA is satisfied that a person has contravened an ISO rule. Specified penalties are set out in AUC Rule 019.

In accordance with the relevant enactments and rules, a dispute regarding the issuance of a Notice of Specified Penalty or failure to pay the specified penalty in accordance with this notice will result in a hearing or other proceeding before the AUC.

In accordance with s. 5(1) of AUC Rule 019 this Notice of Specified Penalty will be made public no earlier than receipt of confirmation of payment from the Commission and no later than 45 days after issuance. The MSA will, if applicable, also post on its website the link to any decision of the AUC respecting the specified penalty.
