### EVENT DETAILS

On January 7, 2017 during the HE 23 settlement period, the ME02 generating asset was dispatched to provide 8 MW of supplemental reserves generation (SUPG). At approximately 22:21, ME02 received an ancillary services directive to increase its generation by 8 MW. In the 10 minute period following the directive, ME02 increased generation by less than the directed amount. ISO rule section 205.6 indicates that a pool participant must ensure that after receiving a directive to provide supplemental reserve, the asset is providing the quantity of real power equal to the instantaneous amount of real power of the asset at the time of the directive plus the amount of real power set out in the directive, no later than ten minutes after receiving the directive.

### FINDINGS

Based upon the information obtained by the MSA, the MSA is satisfied that the event was a contravention of ISO Rule 205.6.

### MATERIAL FACTS

The material facts relied upon by the MSA include the following:

1. AESO generation, dispatch, and ancillary service directive data for ME02 for January 7, 2017.
2. AESO information request issued to Signalta Resources Limited dated March 20, 2017.
3. URICA Energy Real Time Ltd.'s response to AESO information request on behalf of Signalta Resources Limited dated March 29, 2017.
4. Referral from the AESO to the MSA dated March 30, 2017.
5. Additional submission from URICA Energy Real Time Ltd. to the MSA on behalf of Signalta Resources Limited dated April 3, 2017.

### NOTICE

The Market Surveillance Administrator (MSA) is granted the power and authority under s. 52 of the *Alberta Utilities Commission Act* to issue a Notice of Specified Penalty where the MSA is satisfied that a person has contravened an ISO rule. Specified penalties are set out in AUC Rule 019.

In accordance with the relevant enactments and rules, a dispute regarding the issuance of a Notice of Specified Penalty or failure to pay the specified penalty in accordance with this notice will result in a hearing or other proceeding before the AUC.

In accordance with s. 5(1) of AUC Rule 019 this Notice of Specified Penalty will be made public no earlier than receipt of confirmation of payment from the Commission and no later than 45 days after issuance. The MSA will, if applicable, also post on its website the link to any decision of the AUC respecting the specified penalty.
