#### **EVENT DETAILS**

On December 10, 2017 at approximately 19:51, the BIG generating asset was directed to provide 35 MW of spinning reserve. BIG did not provide a quantity of real power equal to the instantaneous amount of real power of the pool asset at the time of the directive plus the amount of real power set out in the directive within ten minutes after receiving the directive. Subsection 7(1) of section 205.5 of the ISO rules states:

A pool participant must, within ten (10) minutes after receiving a directive to provide spinning reserve, ensure that the pool asset is providing a quantity of real power equal to the instantaneous amount of real power of the pool asset at the time of the directive plus the amount of real power set out in the directive, as measured in accordance with subsection 3(4).

### **FINDINGS**

Based upon the information obtained by the MSA, the MSA is satisfied that the event was a contravention of ISO rule 205.5.

## **MATERIAL FACTS**

The material facts relied upon by the MSA include the following:

- 1. AESO generation, dispatch and directive data for BIG for December 10, 2017.
- 2. AESO information request issued to TransAlta Generation Partnership dated March 26, 2018.
- 3. TransAlta Generation Partnership's response to the AESO information request dated April 11, 2018.
- 4. Referral from the AESO to the MSA dated April 23, 2018.
