### **EVENT DETAILS**

On March 15, 2018 at approximately 20:55, the NAT1 generating asset was directed to provide 5 MW of supplemental reserve. NAT1 did not provide a quantity of real power equal to the instantaneous amount of real power of the pool asset at the time of the directive and the amount of real power set out in the directive within ten minutes following receipt of the directive. Subsection 6(1) of section 205.6 of the ISO rules states:

A pool participant must, within ten (10) minutes following receipt of a directive to provide supplemental reserve, ensure that its pool asset is providing a quantity of real power equal to the instantaneous amount of real power of the pool asset at the time of the directive and the amount of real power set out in the directive.

# **FINDINGS**

Based upon the information obtained by the MSA, the MSA is satisfied that the event was a contravention of ISO rule 205.6.

# **MATERIAL FACTS**

The material facts relied upon by the MSA include the following:

- 1. AESO generation, dispatch and directive data for NAT1 for March 15, 2018.
- Self-report submitted by URICA Energy Real Time Ltd. on behalf of NAT-1 Limited Partnership to the MSA dated May 10, 2018.

# NOTICE
