EVENT DETAILS

On June 22, 2018 at approximately 15:39, the VVW2 generating asset was directed to provide 33 MW of spinning reserve. VVW2 did not provide a quantity of real power equal to the instantaneous amount of real power of the pool asset at the time of the directive and the amount of real power set out in the directive within ten minutes following receipt of the directive. Subsection 10(1) of section 205.5 of the ISO rules states:

A pool participant must, within ten (10) minutes following receipt of a directive to provide spinning reserve, ensure that its pool asset is providing a quantity of real power equal to the instantaneous amount of real power of the pool asset at the time of the directive and the amount of real power set out in the directive.

FINDINGS

Based upon the information obtained by the MSA, the MSA is satisfied that the event was a contravention of ISO rule 205.5.

MATERIAL FACTS

The material facts relied upon by the MSA include the following:

- 1. AESO generation, dispatch and directive data for VVW2 for June 22, 2018.
- 2. Self-report submitted by ATCO Power Canada Ltd. to the MSA dated July 20, 2018.
- Additional information provided by ATCO Power Canada Ltd. to the MSA dated October 24, 2018 in response to a MSA communication dated October 23, 2018.

NOTICE

In accordance with s. 5(1) of AUC Rule 019 this Notice of Specified Penalty will be made public no earlier than receipt of confirmation of payment from the Commission and no later than 45 days after issuance. The MSA will, if applicable, also post on its website the link to any decision of the AUC respecting the specified penalty.
