EVENT DETAILS

On August 1, 2018 at approximately 15:47, a minimum stable generation (MSG) restatement was made for the SD4 generating asset reducing the MSG from 200 MW to 150 MW for the hour ending (HE) 16 and 17 settlement intervals on the same date. Concurrently, MW restatements were submitted for the same settlement intervals resulting in the movement of 50 MW from operating block 0 into operating block 1. Subsection 5(2) of section 203.3 of the ISO rules states:

If the restated minimum stable generation:

- (a) is lower than the previously submitted minimum stable generation; and
- (b) the restatement is submitted within two (2) hours of the start of the settlement interval,

then the pool participant is prohibited from restating the MW of the operating block with the lowest offer price for the source asset.

FINDINGS

Based upon the information obtained by the MSA, the MSA is satisfied that the event was a contravention of ISO rule 203.3.

MATERIAL FACTS

The material facts relied upon by the MSA include the following:

- 1. AESO minimum stable generation and energy offer data for SD4 for August 1, 2018.
- 2. AESO information request issued to TransAlfa Generation Partnership dated December 4, 2018.
- 3. TransAlta Generation Partnership's response to the AESO information request dated December 18, 2018.
- 4. Referral from the AESO to the MSA dated December 20, 2018.

NOTICE

The Market Surveillance Administrator (MSA) is granted the power and authority under s. 52 of the *Alberta Utilities Commission Act* to issue a Notice of Specified Penalty where the MSA is satisfied that a person has contravened an ISO rule. Specified penalties are set out in AUC Rule 019.

In accordance with the relevant enactments and rules, a dispute regarding the issuance of a Notice of Specified Penalty or failure to pay the specified penalty in accordance with this notice will result in a hearing or other proceeding before the AUC.

In accordance with s. 5(1) of AUC Rule 019 this Notice of Specified Penalty will be made public no earlier than receipt of confirmation of payment from the Commission and no later than 45 days after issuance. The MSA will, if applicable, also post on its website the link to any decision of the AUC respecting the specified penalty.
