EVENT DETAILS

On November 9, 2018 at approximately 08:56, the ALS1 generating asset was directed to provide 6 MW of spinning reserve. ALS1 did not provide a quantity of real power equal to the instantaneous amount of real power of the pool asset at the time of the directive and the amount of real power set out in the directive within ten minutes following receipt of the directive. Subsection 10(1) of section 205.5 of the ISO rules states:

A pool participant must, within ten (10) minutes following receipt of a directive to provide spinning reserve, ensure that its pool asset is providing a quantity of real power equal to the instantaneous amount of real power of the pool asset at the time of the directive and the amount of real power set out in the directive.

FINDINGS

Based upon the information obtained by the MSA, the MSA is satisfied that the event was a contravention of ISO rule 205.5.

MATERIAL FACTS

The material facts relied upon by the MSA include the following:

- 1. AESO generation, dispatch and directive data for ALS1 for November 9, 2018.
- 2. Self-report submitted by Air Liquide Canada Inc. to the MSA dated December 7, 2018.

DELIVERY OF PAYMENT

NOTICE
