EVENT DETAILS

On November 16, 2018, VOCG had a contract to provide supplemental reserve from load for HE 08 through HE 23. At this time VOCG had no load and was not in a position to provide supplemental reserves. At approximately 08:45, Voltus submitted a restatement substituting their supplemental reserve contract from VOCG to VOED, for HE 11 through HE 23. Voltus did not restate their supplemental reserve contract on VOCG for HE 08 through HE 10. Section 205.3 of the ISO Rules states in part:

- 3(4) A pool participant that submits an offer must, as soon as reasonably practicable, submit a restatement to represent the operating state of the pool asset if:
- (a) the pool asset is no longer able to deliver the MW set out in the offer; or
 - (b) the pool participant is not able to meet the requirements set out in Section 205.4 of the ISO rules, *Regulating Reserve Technical Requirements and Performance Standards*, Section 205.5 of the ISO rules, *Spinning Reserve Technical Requirements and Performance Standards* or Section 205.6 of the ISO rules, *Supplemental Reserve Technical Requirements and Performance Standards*, as applicable.

FINDINGS

Based upon the information obtained by the MSA, the MSA is satisfied that the event was a contravention of ISO rule 205.3.

MATERIAL FACTS

The material facts relied upon by the MSA include the following:

1. AESO ancillary services data for VOCG and VOED for November 16, 2018.
2. Referral from the AESO to the MSA dated June 7, 2019, and the associated documents which additionally include:
 - (a) AESO information request to Voltus Energy Canada Ltd., dated April 18, 2019.
 - (b) Voltus Energy Canada Ltd.'s response to the AESO information request, dated May 7, 2019.
3. Additional information memo submitted from Voltus to the MSA, dated June 28, 2019.

DELIVERY OF PAYMENT

NOTICE

The Market Surveillance Administrator (MSA) is granted the power and authority under s. 52 of the *Alberta Utilities Commission Act* to issue a Notice of Specified Penalty where the MSA is satisfied that a person has contravened an ISO rule. Specified penalties are set out in AUC Rule 019.

In accordance with the relevant enactments and rules, a dispute regarding the issuance of a Notice of Specified Penalty or failure to pay the specified penalty in accordance with this notice will result in a hearing or other proceeding before the AUC.

In accordance with s. 5(1) of AUC Rule 019 this Notice of Specified Penalty will be made public no earlier than receipt of confirmation of payment from the Commission and no later than 45 days after issuance. The MSA will, if applicable, also post on its website the link to any decision of the AUC respecting the specified penalty.
