EVENT DETAILS

At 00:42 on February 19, 2019 SCR4 received an advanced dispatch for HE02 to 45 MW of energy. However, there was no response and the dispatch timed out. Additional dispatches with the same energy level were sent at 00:49, 00:51 and 1:03 but these dispatches all timed out with no response. The AESO sent another dispatch at 1:06 and this was accepted. Subsection 5 of section 201.7 of the ISO rules states in part:

A pool participant must acknowledge receipt of a dispatch:

- (a) in the case of an automated message and unless the pool participant has notified the ISO of an unavailability in accordance with subsection 4(1)(a) by responding via the Automated Dispatch and Messaging System:
- (i) within two (2) minutes for an intra-Alberta transaction;

FINDINGS

Based upon the information obtained by the MSA, the MSA is satisfied that the event was a contravention of ISO rule 201.7.

MATERIAL FACTS

The material facts relied upon by the MSA include the following:

- 1. AESO dispatch and available capability data for SCR4 for February 19, 2019.
- 2. Self-report submitted by Oldman 2 Wind Farm Limited to the MSA dated June 14, 2019.

DELIVERY OF PAYMENT

NOTICE
