EVENT DETAILS

Over a period spanning from November 3, 2018, HE 07 through November 9, 2018, HE 17, the HRM asset was dispatched for 0 MW of energy. For several of the 10 minute clock periods during this time period, HRM varied its average generation from this energy dispatch by more than its allowable dispatch variance. Section 203.4 of the ISO rules states in part:

3(1) A pool participant must not, during generating asset steady state, vary the average MW it delivers from a generating source asset in any 10 minute clock period from the dispatch MW by more than the allowable dispatch variance.

FINDINGS

Based upon the information obtained by the MSA, the MSA is satisfied that the event was a contravention of ISO rule 203.4.

MATERIAL FACTS

The material facts relied upon by the MSA include the following:

1. AESO available capability, dispatch, generation, phone calls between HRM and the AESO, and energy offers data for HRM for November 3 through 9, 2018.
2. AESO information request issued to Milner Power Limited Partnership by its General Partner Milner Power Inc., dated April 17, 2019.
3. Milner Power Limited Partnership by its General Partner Milner Power Inc.'s response to the AESO information request, dated May 15, 2019.
4. Referral from the AESO to the MSA dated June 27, 2019.

DELIVERY OF PAYMENT

Payment by cheque or certified funds is to be made out to the "General Revenue Fund c/o Minister of Finance", and delivered to the Alberta Utilities Commission (AUC) at: 1400, 600 – 3rd Avenue S.W., Calgary, Alberta, T2P 0G5. NOTICE

The Market Surveillance Administrator (MSA) is granted the power and authority under s. 52 of the *Alberta Utilities Commission Act* to issue a Notice of Specified Penalty where the MSA is satisfied that a person has contravened an ISO rule. Specified penalties are set out in AUC Rule 019.

In accordance with the relevant enactments and rules, a dispute regarding the issuance of a Notice of Specified Penalty or failure to pay the specified penalty in accordance with this notice will result in a hearing or other proceeding before the AUC.

In accordance with s. 5(1) of AUC Rule 019 this Notice of Specified Penalty will be made public no earlier than receipt of confirmation of payment from the Commission and no later than 45 days after issuance. The MSA will, if applicable, also post on its website the link to any decision of the AUC respecting the specified penalty.
