| On June 20, 2019 at 16:43 BFDH received a directive to provide 37 MW of supplemental load reserves. However, BFDH did not provide the change in quantity of real power that was set out in the directive within ten minutes following receipt of the directive. Subsection 6(1) of section 205.6 of the ISO rules states: | | | | |

6(1) A pool participant must, within ten (10) minutes following receipt of a directive to provide supplemental reserve, ensure that its pool asset is providing a quantity of real power equal to the instantaneous amount of real power of the pool asset at the time of the directive and the amount of real power set out in the directive.

FINDINGS

Based upon the information obtained by the MSA, the MSA is satisfied that the event was a contravention of ISO rule 205.6.

MATERIAL FACTS

The material facts relied upon by the MSA include the following:

- 1. AESO dispatch and directive data for BFDH for June 20, 2019.
- 2. Market Participant consumption data for BFDH from 16:30 to 17:30 on June 20, 2019.
- 3. Self-report submitted by URICA Energy Real Time Ltd. on behalf of Bitfury Technology Inc. to the MSA dated July 4, 2019.

NOTICE
