### **EVENT DETAILS**

On May 31, 2019 at approximately 14:22, the KH2 asset received a directive to provide 10 MW of spinning reserve. However, KH2 did not provide a quantity of real power equal to the instantaneous amount of real power of the pool asset at the time of the directive and the amount of real power set out in the directive within ten minutes following receipt of the directive. Subsection 10 of section 205.5 of the ISO rules states in part:

10(1) A pool participant must, within ten (10) minutes following receipt of a directive to provide spinning reserve, ensure that its pool asset is providing a quantity of real power equal to the instantaneous amount of real power of the pool asset at the time of the directive and the amount of real power set out in the directive.

### **FINDINGS**

Based upon the information obtained by the MSA, the MSA is satisfied that the event was a contravention of ISO rule 205.5.

## **MATERIAL FACTS**

The material facts relied upon by the MSA include the following:

- 1. AESO generation, dispatch, and directive data for KH2 for May 31, 2019.
- 2. Self-report submitted by the Balancing Pool to the MSA dated July 9, 2019.

# NOTICE
