#### **EVENT DETAILS**

On February 26, 2019 at approximately 05:06 the BRA unit was directed by the AESO to provide 80 MW of spinning reserve generation and 40 MW of supplemental reserve generation. However, BRA did not provide a quantity of real power equal to the instantaneous amount of real power of the pool asset at the time of the directive and the amount of real power set out in the directive within ten minutes following receipt of the directive. Subsection 10 of section 205.5 of the ISO rules states in part:

10(1) A pool participant must, within ten (10) minutes following receipt of a directive to provide spinning reserve, ensure that its pool asset is providing a quantity of real power equal to the instantaneous amount of real power of the pool asset at the time of the directive and the amount of real power set out in the directive.

#### **FINDINGS**

Based upon the information obtained by the MSA, the MSA is satisfied that the event was a contravention of ISO rule 205.5.

## **MATERIAL FACTS**

The material facts relied upon by the MSA include the following:

- 1. AESO dispatch, generation and directive data for BRA for February 26, 2019.
- 2. AESO information request issued to TransAlta Generation Partnership, dated July 8, 2019.
- 3. TransAlta Generation Partnership's response to the AESO information request, dated July 19, 2019.
- 4. Referral from the AESO to the MSA dated July 26, 2019.
