EVENT DETAILS

On August 9, 2019 at 07:34, the available capability (AC) of the ME03 asset was restated to 0 MW for HE 09 through HE 24. The asset returned to service in HE 16 but the AC was not restated to reflect the operational capabilities of the asset. The ME03 asset was online generating up to approximately 6 MW between 15:19 and 22:03, despite having a declared AC and energy dispatch of 0 MW. Section 203.3 of the ISO rules states in part:

- (2) A pool participant that submits an offer must, if there is a change to the available capability of the source asset as a result of any of the circumstances outlined in subsections 2(1)(a), (b) or (c), submit an available capability restatement revising the available capability for the applicable hours, as soon as reasonably practicable.
- (3) A pool participant must submit the reason or reasons for submitting an available capability restatement for a source asset.

FINDINGS

Based upon the information obtained by the MSA, the MSA is satisfied that the event was a contravention of ISO rule 203.3.

MATERIAL FACTS

The material facts relied upon by the MSA include the following:

- 1. AESO available capability, dispatch and generation data for ME03 for August 9, 2019.
- 2. Self-report submitted by URICA Energy Real Time on behalf of Signalta Resources Limited to the MSA dated August 14, 2019.

NOTICE

The MSA will, if applicable, also post on its website the link to any decision of the AUC respecting the specified penalty.
