EVENT DETAILS

On April 2, 2019, at approximately 18:34:20, the MGMT asset submitted an available capability restatement, revising the source asset's available capability, from 50 MW to 0 MW with the reason "Non economic", for hour ending 20. Later, at approximately 19:31:43, MGMT submitted a restatement revising its available capability from 50 MW to 0 MW with the reason "Non economic", for hour ending 21. Information available to the MSA indicates that MAG Energy Solutions Inc. submitted an available capability restatement revising the available capability of MGMT where such revision was not as a result of an acceptable operational reason. Section 203.3 of the ISO rules states in part:

- 2(1) A pool participant must only submit an available capability restatement revising the available capability of a source asset if such revision is:
 - (a) as a result of an acceptable operational reason;

FINDINGS

Based upon the information obtained by the MSA, the MSA is satisfied that the event was a contravention of ISO rule 203.3.

MATERIAL FACTS

The material facts relied upon by the MSA include the following:

- 1. AESO available capability, dispatch, generation and energy offer data for MGMT for April 2, 2019.
- 2. AESO information request issued to MAG Energy Solutions Inc., dated August 26, 2019.
- 3. MAG Energy Solutions Inc.'s response to the AESO information request, dated September 9, 2019.
- 4. Referral from the AESO to the MSA dated September 25, 2019.

NOTICE

In accordance with s. 5(1) of AUC Rule 019 this Notice of Specified Penalty will be made public no earlier than receipt of confirmation of payment from the Commission and no later than 45 days after issuance. The MSA will, if applicable, also post on its website the link to any decision of the AUC respecting the specified penalty.
