EVENT DETAILS

Beginning at approximately 14:30 on May 3, 2019, an operational issue affecting the ALP1 asset occurred, requiring restatements of available capability and supplemental reserve to 0 MW. For the settlement intervals HE 24 of May 3 and HE 01 through HE 07 of May 6, however, the offers for supplemental reserve were not restated as soon as reasonably practical. Section 205.3 of the ISO Rules states in part:

- (4) A pool participant that submits an offer must, as soon as reasonably practicable, submit a restatement to represent the operating state of the pool asset if:
- (a) the pool asset is no longer able to deliver the MW set out in the offer; ...

FINDINGS

Based upon the information obtained by the MSA, the MSA is satisfied that the event was a contravention of ISO rule 205.3.

MATERIAL FACTS

The material facts relied upon by the MSA include the following:

- 1. AESO available capability, dispatch and ancillary services offer data for ALP1 for May 3-6, 2019.
- 2. AESO information request issued to Campus Energy Partners LP, dated October 18, 2019.
- 3. Campus Energy Partners LP's response to the AESO information request, dated October 25, 2019.
- 4. Referral from the AESO to the MSA dated November 28, 2019.
- 5. Additional information provided by Campus Energy Partners LP to the MSA dated November 28, 2019.

NOTICE
