#### **EVENT DETAILS**

On March 27, 2019, during the HE 17 and HE 18 settlement intervals, the CNR5 asset varied the average MW it delivered from its dispatch level by more than its allowable dispatch variance, for several 10 minute clock periods. Section 203.4 of the ISO rules states in part:

3(1) A pool participant must not, during generating asset steady state, vary the average MW it delivers from a generating source asset in any 10 minute clock period from the dispatch MW by more than the allowable dispatch variance.

#### **FINDINGS**

Based upon the information obtained by the MSA, the MSA is satisfied that the event was a contravention of section 203.4 of the ISO rules.

## **MATERIAL FACTS**

The material facts relied upon by the MSA include the following:

- 1. AESO available capability, dispatch, generation and offer data for CNR5 for March 27, 2019.
- 2. AESO information request issued to Canadian Natural Resources Ltd., dated August 9, 2019.
- 3. Canadian Natural Resources Ltd.'s response to the AESO information request, dated August 21, 2019.
- 4. Referral from the AESO to the MSA dated December 6, 2019.
- 5. Additional information provided by Canadian Natural Resources Ltd. to the MSA dated December 19, 2019.
