EVENT DETAILS

On December 6, 2019, NorthPoint Energy Solutions Inc. scheduled an energy interchange transaction to import 141 MW of energy for HE 01 through HE 24, on December 7, 2019 from the SPSK asset. On December 6, 2019, NorthPoint Energy Solutions Inc. submitted available capability restatements from 0 MW to 141 MW for HE 01 through HE 24, for both the SPMT asset at 12:01 and for the SPSK asset at 12:35. Information available to the MSA indicates that NorthPoint Energy Solutions Inc. did not submit a correcting available capability restatement for SPMT. Accordingly, NorthPoint Energy Solutions Inc. did not make a submission through the Energy Trading System, as applicable, to satisfy the requirements of section 203.6 of the ISO rules. Section 203.6 of the ISO rules states, in part:

5(1) Notwithstanding subsection 3.5.2 of the ISO rules, Submission Timing, a pool participant with an import or export energy interchange transaction must submit through the Energy Trading System the import offer or export bid for the interchange transaction, as applicable, no later than two (2) hours prior to the start of the settlement interval in order for the interchange transaction to be included in the energy market merit order.

FINDINGS

Based upon the information obtained by the MSA, the MSA is satisfied that the event was a contravention of section 203.6 of the ISO rules.

MATERIAL FACTS

The material facts relied upon by the MSA include the following:

- 1. AESO available capability data, for SPMT for December 6 through 7, 2019.
- 2. Self-report submitted by NorthPoint Energy Solutions Inc. to the MSA dated December 30, 2019.

NOTICE

The Market Surveillance Administrator (MSA) is granted the power and authority under s. 52 of the Alberta Utilities Commission Act to issue a Notice of Specified Penalty where the MSA is satisfied that a person has contravened an ISO rule. Specified penalties are set out in AUC Rule 019.

In accordance with the relevant enactments and rules, a dispute regarding the issuance of a Notice of Specified Penalty or failure to pay the specified penalty in accordance with this notice will result in a hearing or other proceeding before the AUC.

In accordance with s. 5(1) of AUC Rule 019 this Notice of Specified Penalty will be made public no earlier than receipt of confirmation of payment from the Commission and no later than 45 days after issuance. The MSA will, if applicable, also post on its website the link to any decision of the AUC respecting the specified penalty.
