EVENT DETAILS

On January 15, 2020, at approximately 16:05, TransAlta Generation Partnership submitted an available capability restatement in relation to its KH3 asset, to 450 MW. At approximately 16:07, KH3 received and accepted an energy dispatch for 450 MW. During a period spanning from approximately 16:10 through 17:39, KH3 varied the average MW it delivered by more than its allowable dispatch variance. Section 203.4 of the ISO rules states in part:

3(1) A pool participant must not, during generating asset steady state, vary the average MW it delivers from a generating source asset in any 10 minute clock period from the dispatch MW by more than the allowable dispatch variance.

FINDINGS

Based upon the information obtained by the MSA, the MSA is satisfied that the event was a contravention of section 203.4 of the ISO rules.

MATERIAL FACTS

The material facts relied upon by the MSA include the following:

- 1. AESO available capability, dispatch, generation and offer data for KH3 for January 15, 2020.
- 2. Self-report submitted by TransAlta Generation Partnership to the MSA dated January 16, 2020.

NOTICE
