EVENT DETAILS

Following advanced dispatches for the HE 01 settlement intervals, available capability (AC) restatements for the HMT1 generating asset were submitted within one hour prior to the start of the HE 01 settlement intervals of July 3, 5, 9, 10, 13, 17, 25 and 28, 2019 changing the AC of the HE 01 settlement intervals. Information available to the MSA indicates that these restatements were not made as soon as reasonably practicable. Section 203.3 of the ISO rules states in part:

2(2) A pool participant that submits an offer must, if there is a change to the available capability of the source asset as a result of any of the circumstances outlined in subsections 2(1)(a), (b) or (c), submit an available capability restatement revising the available capability for the applicable hours, as soon as reasonably practicable.

FINDINGS

Based upon the information obtained by the MSA, the MSA is satisfied that the event was a contravention of section 203.3 of the ISO rules.

MATERIAL FACTS

The material facts relied upon by the MSA include the following:

- 1. AESO available capability, dispatch and offer data for HMT1 for July 3, 5, 9, 10, 13, 17, 25 and 28, 2019.
- 2. AESO information request issued to AltaGas Ltd., dated December 12, 2019.
- 3. AltaGas Ltd.'s response to the AESO information request, dated January 2, 2020.
- 4. Referral from the AESO to the MSA dated January 24, 2020.

NOTICE

In accordance with the relevant enactments and rules, a dispute regarding the issuance of a Notice of Specified Penalty or failure to pay the specified penalty in accordance with this notice will result in a hearing or other proceeding before the AUC.

In accordance with s. 5(1) of AUC Rule 019 this Notice of Specified Penalty will be made public no earlier than receipt of confirmation of payment from the Commission and no later than 45 days after issuance. The MSA will, if applicable, also post on its website the link to any decision of the AUC respecting the specified penalty.
