EVENT DETAILS

On April 27, 2020, during the HE 15 through HE 19 settlement intervals, the FNG1 asset received 13 energy dispatches which it did not acknowledge receipt of within two minutes. Section 201.7 of the ISO rules states in part:

- 5 A pool participant must acknowledge receipt of a dispatch:
 - (a) in the case of an automated message and unless the pool participant has notified the ISO of an unavailability in accordance with subsection 4(1)(a) by responding via the Automated Dispatch and Messaging System:
 - (i) within two (2) minutes for an intra-Alberta transaction; [...]

FINDINGS

Based upon the information obtained by the MSA, the MSA is satisfied that the event was a contravention of section 201.7 of the ISO rules.

MATERIAL FACTS

The material facts relied upon by the MSA include the following:

- 1. AESO dispatch data for FNG1 for April 27, 2020.
- 2. Self-report submitted by Powerex Corp. to the MSA dated May 6, 2020.

NOTICE
