# **EVENT DETAILS**

From April 15 through 21, 2020, the Alberta Electric System Operator experienced periodic losses of its emergency and back up communications system. The AESO did not give verbal notice to all affected market participants during the period from April 15 through April 23, 2020. Section 502.4 of the ISO rules states in part:

10(1) If either the ISO or a market participant experiences a material disruption or complete loss of any emergency and back up communication systems at a point in time other than during a test period, then verbal notice must be given by:

(a) the ISO to all affected market participants, if the ISO suffers the disruption of loss; or

### **FINDINGS**

Based upon the information obtained by the MSA, the MSA is satisfied that the event was a contravention of section 502.4 of the ISO rules.

### **MATERIAL FACTS**

The material facts relied upon by the MSA include the following:

1. Self-report submitted by Alberta Electric System Operator to the MSA dated May 13, 2020.

## NOTICE

The Market Surveillance Administrator (MSA) is granted the power and authority under s. 52 of the *Alberta Utilities Commission Act* to issue a Notice of Specified Penalty where the MSA is satisfied that a person has contravened an ISO rule. Specified penalties are set out in AUC Rule 019.

In accordance with the relevant enactments and rules, a dispute regarding the issuance of a Notice of Specified Penalty or failure to pay the specified penalty in accordance with this notice will result in a hearing or other proceeding before the AUC.

In accordance with s. 5(1) of AUC Rule 019 this Notice of Specified Penalty will be made public no earlier than receipt of confirmation of payment from the Commission and no later than 45 days after issuance. The MSA will, if applicable, also post on its website the link to any decision of the AUC respecting the specified penalty.
