EVENT DETAILS

- 1) On January 13, 2020, during the HE 12, 22, and 23 settlement intervals, the SDH1 generating asset received 19 energy dispatches that it did not acknowledge receipt of within two minutes.
- 2) On January 15, 2020, during the HE 9 and 10 settlement intervals, the SDH1 generating asset received nine energy dispatches which it did not acknowledge receipt of within two minutes.

Section 201.7 of the ISO rules states, in part:

5 A pool participant must acknowledge receipt of a dispatch:

- (a) in the case of an automated message and unless the pool participant has notified the ISO of an unavailability in accordance with subsection 4(1)(a) by responding via the Automated Dispatch and Messaging System:
- (i) within two (2) minutes for an intra-Alberta transaction; and

FINDINGS

Based upon the information obtained by the MSA, the MSA is satisfied that the event was a contravention of section 201.7 of the ISO rules.

MATERIAL FACTS

The material facts relied upon by the MSA include the following:

1. AESO dispatch data for SDH1 for January 13 and 15, 2020.
2. AESO information requests issued to Tourmaline Oil Corp., dated June 10, 2020.
3. Tourmaline Oil Corp.'s response to the AESO information requests, dated June 23, 2020.
4. Referrals from the AESO to the MSA dated July 22, 2020.
5. Additional information submitted by Tourmaline Oil Corp. to the MSA dated July 24, 2020.

DELIVERY OF PAYMENT

NOTICE

The Market Surveillance Administrator (MSA) is granted the power and authority under s. 52 of the *Alberta Utilities Commission Act* to issue a Notice of Specified Penalty where the MSA is satisfied that a person has contravened an ISO rule. Specified penalties are set out in AUC Rule 019.

In accordance with the relevant enactments and rules, a dispute regarding the issuance of a Notice of Specified Penalty or failure to pay the specified penalty in accordance with this notice will result in a hearing or other proceeding before the AUC.

In accordance with s. 5(1) of AUC Rule 019 this Notice of Specified Penalty will be made public no earlier than receipt of confirmation of payment from the Commission and no later than 45 days after issuance. The MSA will, if applicable, also post on its website the link to any decision of the AUC respecting the specified penalty.
