EVENT DETAILS

On March 13, 2020, at approximately 15:45:42, the SD4 asset received a directive to provide 68 MW of spinning reserve. Ten minutes following the directive, the increase in real power from SD4 was less than the directed amount. Section 205.5 of the ISO rules states in part:

10(1) A pool participant must, within ten (10) minutes following receipt of a directive to provide spinning reserve, ensure that its pool asset is providing a quantity of real power equal to the instantaneous amount of real power of the pool asset at the time of the directive and the amount of real power set out in the directive.

FINDINGS

Based upon the information obtained by the MSA, the MSA is satisfied that the event was a contravention of section 205.5 of the ISO rules.

MATERIAL FACTS

The material facts relied upon by the MSA include the following:

- 1. AESO available capability, dispatch, generation and offer data for SD4 for March 13, 2020.
- 2. AESO information request issued to TransAlta Generation Partnership dated July 16, 2020.
- 3. TransAlta Generation Partnership's response to the AESO information request dated July 24, 2020.
- 4. Referral from the AESO to the MSA dated July 30, 2020.
- 5. Additional information provided by TransAlta Generation Partnership to the MSA dated November 18, 2020.

NOTICE

The Market Surveillance Administrator (MSA) is granted the power and authority under s. 52 of the *Alberta Utilities Commission Act* to issue a Notice of Specified Penalty where the MSA is satisfied that a person has contravened an ISO rule. Specified penalties are set out in AUC Rule 019.
