## **EVENT DETAILS**

On November 5, 2020, at approximately 03:09:10, the SH2 asset received a directive to provide 20 MW of spinning reserve. Ten minutes following the directive, the increase in real power from SH2 was less than the directed amount. Section 205.5 of the ISO rules states in part:

10(1) A pool participant must, within ten (10) minutes following receipt of a directive to provide spinning reserve, ensure that its pool asset is providing a quantity of real power equal to the instantaneous amount of real power of the pool asset at the time of the directive and the amount of real power set out in the directive.

#### **FINDINGS**

Based upon the information obtained by the MSA, the MSA is satisfied that the event was a contravention of section 205.5 of the ISO rules.

### **MATERIAL FACTS**

The material facts relied upon by the MSA include the following:

- 1. AESO available capability, dispatch, directive, generation and offer data for SH2 for November 5, 2020.
- 2. Self-report submitted by the Balancing Pool to the MSA dated November 27, 2020.

# NOTICE
