EVENT DETAILS

On March 28, 2021, at approximately 23:10:40, the GN2 asset received a directive to provide 25 MW of spinning reserve. From the first time GN2 achieved the required response to the time fifteen minutes following receipt of the directive, the asset was providing an average response less than the amount of real power set out in the directive. Section 205.5 of the ISO rules states, in part:

10(2) A pool participant must ensure that, from the first time its pool asset achieves the response set out in subsection 10(1) to the time fifteen (15) minutes following receipt of the directive, the pool asset is providing an average response equal to or greater than the amount of real power set out in the directive.

FINDINGS

Based upon the information obtained by the MSA, the MSA is satisfied that the event was a contravention of section 205.5 of the ISO rules.

MATERIAL FACTS

The material facts relied upon by the MSA include the following:

1. AESO available capability, dispatch, directive, generation and offer data for GN2 for March 28, 2021.
2. Self-report submitted by Capital Power (Genesee) L.P. to the MSA dated April 27, 2021.

DELIVERY OF PAYMENT

NOTICE

The Market Surveillance Administrator (MSA) is granted the power and authority under s. 52 of the *Alberta Utilities Commission Act* to issue a Notice of Specified Penalty where the MSA is satisfied that a person has contravened an ISO rule. Specified penalties are set out in AUC Rule 019.

In accordance with the relevant enactments and rules, a dispute regarding the issuance of a Notice of Specified Penalty or failure to pay the specified penalty in accordance with this notice will result in a hearing or other proceeding before the AUC.

In accordance with s. 5(1) of AUC Rule 019 this Notice of Specified Penalty will be made public no earlier than receipt of confirmation of payment from the Commission and no later than 45 days after issuance. The MSA will, if applicable, also post on its website the link to any decision of the AUC respecting the specified penalty.
