EVENT DETAILS				
On July 18, 2021, at approximately 00:28, the VOCG asset received a directive to provide 23 MW of supplemental reserve supplied by load. Ten minutes following the directive, the reduction of load from VOCG was less than the directed amount, and over the course of the directive, the asset did not provide a response in accordance with the following subsections. Section 205.6 of the ISO rules states, in part: 6(1) A pool participant must, within ten (10) minutes following receipt of a directive to provide supplemental reserve, ensure that its pool asset is providing a quantity of real power equal to the instantaneous amount of real power of the pool asset at the time of the directive and the amount of real power set out in the directive. (2) A pool participant must ensure that, from the first time its pool asset achieves the response set out in subsection 6(1) to the time fifteen (15) minutes following receipt of the directive, the pool asset is providing an average response equal to or greater than the amount of real power set out in the directive.				
FINDINGS				
Based upon the information obtained by the MSA, the MSA is satisfied that the event was a contravention of section 205.6 of the ISO rules.
