EVENT DETAILS

On March 22, 2021, at approximately 18:03:25, the KH1 asset received a directive to provide 70 MW of spinning reserve. For each consecutive ten-minute interval beginning fifteen minutes following receipt of the directive, the average response was greater than the tolerance specified in section 205.5. Section 205.5 of the ISO rules states in part:

10(3) A pool participant must ensure that, for each consecutive ten (10) minute interval beginning fifteen (15) minutes following receipt of a directive, the average response from the pool asset equals the amount of real power set out in the directive, within a tolerance of plus or minus:

[...]

(b) 10 MW for a pool asset with a maximum capability of greater than 200 MW.

FINDINGS

Based upon the information obtained by the MSA, the MSA is satisfied that the event was a contravention of section 205.5 of the ISO rules.

MATERIAL FACTS

The material facts relied upon by the MSA include the following:

- 1. AESO available capability, dispatch, directive, generation and offer data for KH1 for March 22, 2021.
- 2. AESO information request issued to TransAlta Generation Partnership, dated September 23, 2021.
- 3. TransAlta Generation Partnership's response to the AESO information request, dated October 5, 2021.
- 4. Referral from the AESO to the MSA dated November 22, 2021.
