#### **EVENT DETAILS**

On July 7, 2021, during the HE 11 and HE 12 settlement intervals, 13 dispatches issued for the HMT1 asset were not acknowledged within two minutes of receipt. Section 201.7 of the ISO rules states, in part:

- 5 A pool participant must acknowledge receipt of a dispatch:
  - (a) in the case of an automated message and unless the pool participant has notified the ISO of an unavailability in accordance with subsection 4(1)(a) by responding via the Automated Dispatch and Messaging System:
    - (i) within two (2) minutes for an intra-Alberta transaction; and

### **FINDINGS**

Based upon the information obtained by the MSA, the MSA is satisfied that the event was a contravention of section 201.7 of the ISO rules.

- 2. AESO information request issued to AltaGas Ltd., dated December 16, 2021.
- 3. AltaGas Ltd.'s response to the AESO information request, dated December 17, 2021.
- 4. Referral from the AESO to the MSA, dated March 23, 2022.
