EVENT DETAILS

On October 27, 2021, during the HE 08 and 09 settlement intervals, eleven dispatches were issued for the TLM2 asset and were not acknowledged within two minutes of receipt. Section 201.7 of the ISO rules states in part:

5 A pool participant must acknowledge receipt of a dispatch:

(a) in the case of an automated message and unless the pool participant has notified the ISO of an unavailability in accordance with subsection 4(1)(a) by responding via the Automated Dispatch and Messaging System:

(i) within two (2) minutes for an intra-Alberta transaction; and

FINDINGS

Based upon the information obtained by the MSA, the MSA is satisfied that the event was a contravention of section 201.7 of the ISO rules.

MATERIAL FACTS

The material facts relied upon by the MSA include the following:

1. AESO dispatch data for TLM2 for October 27, 2021.
2. AESO information request issued to Repsol Canada Energy Partnership, dated May 31, 2022.
3. Repsol Canada Energy Partnership's response to the AESO information request, dated June 3, 2022.
4. Referral from the AESO to the MSA dated June 9, 2022.

DELIVERY OF PAYMENT

NOTICE

The Market Surveillance Administrator (MSA) is granted the power and authority under s. 52 of the *Alberta Utilities Commission Act* to issue a Notice of Specified Penalty where the MSA is satisfied that a person has contravened an ISO rule. Specified penalties are set out in AUC Rule 019.

In accordance with the relevant enactments and rules, a dispute regarding the issuance of a Notice of Specified Penalty or failure to pay the specified penalty in accordance with this notice will result in a hearing or other proceeding before the AUC.

In accordance with s. 5(1) of AUC Rule 019 this Notice of Specified Penalty will be made public no earlier than receipt of confirmation of payment from the Commission and no later than 45 days after issuance. The MSA will, if applicable, also post on its website the link to any decision of the AUC respecting the specified penalty.
