EVENT DETAILS

On May 13, 2022, at approximately 12:22, the declared available capability (AC) of the BR5 asset was 0 MW for the May 16, 2022 HE 01 through 12 settlement intervals until approximately 04:59 on May 15, 2022, when the AC was restated to 385 MW for the May 16, 2022 HE 01 through 12 settlement intervals. Information available to the MSA indicates that the revision to 0 MW was not a result of an acceptable operational reason. Section 203.3 of the ISO rules states in part:

2(1) A pool participant must only submit an available capability restatement revising the available capability of a source asset if such revision is:

- (a) as a result of an acceptable operational reason;

FINDINGS

Based upon the information obtained by the MSA, the MSA is satisfied that the event was a contravention of section 203.3 of the ISO rules.

MATERIAL FACTS

The material facts relied upon by the MSA include the following:

1. AESO available capability, dispatch, generation and offer data for BR5 for May 16, 2022.
2. Self-report submitted by Heartland Generation Ltd. on behalf of Alberta Power (2000) Ltd. to the MSA dated June 13, 2022.

DELIVERY OF PAYMENT

NOTICE

The Market Surveillance Administrator (MSA) is granted the power and authority under s. 52 of the *Alberta Utilities Commission Act* to issue a Notice of Specified Penalty where the MSA is satisfied that a person has contravened an ISO rule. Specified penalties are set out in AUC Rule 019.

In accordance with the relevant enactments and rules, a dispute regarding the issuance of a Notice of Specified Penalty or failure to pay the specified penalty in accordance with this notice will result in a hearing or other proceeding before the AUC.

In accordance with s. 5(1) of AUC Rule 019 this Notice of Specified Penalty will be made public no earlier than receipt of confirmation of payment from the Commission and no later than 45 days after issuance. The MSA will, if applicable, also post on its website the link to any decision of the AUC respecting the specified penalty.
