EVENT DETAILS

For the HE 04 settlement interval on September 17, 2022, applicable e-tags were not received by the ISO twenty minutes prior to the start of the settlement interval. Section 203.6 of the ISO rules states, in part:

- 6(1) A pool participant with any import or export interchange transactions that has acquired transmission service must submit e-tags to the ISO for the interchange transactions.
- 6(2) The ISO must receive e-tags no later than twenty (20) minutes prior to the start of the settlement interval in order for the energy components of the interchange transactions to be included in an interchange schedule referenced in subsection 8.

FINDINGS

Based upon the information obtained by the MSA, the MSA is satisfied that the event was a contravention of section 203.6 of the ISO rules.

MATERIAL FACTS

The material facts relied upon by the MSA include the following:

- 1. AESO available capability, offer, and interchange data for PWBC for September 17, 2022.
- 2. Self-report submitted by Powerex Corp. to the MSA dated October 12, 2022.

NOTICE
