#### **MSA FINDINGS**

From October 1, 2022 to November 30, 2022, potential real power capability data was reported from the HYS1 asset. These data do not fall within the required 2.3 MW accuracy requirement. On several days within the period the HYS1 asset reported potential real power capability that was lower than physical energy delivered, by a margin greater than 2.3 MW.

Section 502.8 of the ISO rules states, in part:

2 The legal owner of a generating unit, aggregated generating facility, transmission facility, or a load facility that is energized and commissioned on or after April 7, 2017 must ensure the facility meets the minimum supervisory control and data acquisition requirements of this Section 502.8 and, where applicable, verify with the ISO that the facility meets the requirements during commissioning and before energization.

## [...]

7(5) A legal owner must, if it is providing analog values to the ISO, provide those values with the following minimum accuracy and resolution as specified in Table 2.

Table 2 requires that potential real power capability is reported with an accuracy of +/-10%. As the Maximum Capability (MC) for HYS1 is declared to be 23 MW the required real power capability accuracy is 2.3 MW.

The MSA is satisfied that the conduct was a contravention of section 502.8 of the ISO rules.

NOTICE

The Market Surveillance Administrator (MSA) is granted the power and authority under s. 52 of the *Alberta Utilities Commission Act* to issue a Notice of Specified Penalty where the MSA is satisfied that a person has contravened an ISO rule. Specified penalties are set out in AUC Rule 019.

In accordance with s. 5.1 of AUC Rule 019 this Notice of Specified Penalty will be made public no earlier than receipt of confirmation of payment from the Commission and no later than 45 days after issuance. The MSA will, if applicable, also post on its website the link to any decision of the AUC respecting the specified penalty.
