MSA FINDINGS

On August 31st, 2023, at approximately 16:42, SD6 accepted a dispatch for 270 MW of energy effective at 16:42:00. The pool participant did not move the output of SD6 towards the MW level indicated in the dispatch until approximately 18:37:00. Section 203.4 of the ISO rules states, in part:

- 4(1) A pool participant must move the output of a generating source asset which is:
- (a) the subject of a dispatch; and
- (b) ramping

towards the MW level indicated in that dispatch within 10 minutes of the time specified in the dispatch but not prior to the time specified in the dispatch.

The MSA is satisfied that the conduct was a contravention of section 203.4 of the ISO rules.

NOTICE

The Market Surveillance Administrator (MSA) is granted the power and authority under s. 52 of the *Alberta Utilities Commission Act* to issue a Notice of Specified Penalty where the MSA is satisfied that a person has contravened an ISO rule. Specified penalties are set out in AUC Rule 019.

In accordance with the relevant enactments and rules, a dispute regarding the issuance of a Notice of Specified Penalty or failure to pay the specified penalty in accordance with this notice will result in a hearing or other proceeding before the AUC.

In accordance with s. 5.1 of AUC Rule 019 this Notice of Specified Penalty will be made public no earlier than receipt of confirmation of payment from the Commission and no later than 45 days after issuance.
