## **MSA FINDINGS**

On December 6, 2023, at approximately 8:05:00, the ENCG asset received a directive to provide 50 MW of supplemental reserve. Ten and 15 minutes following the directive, the quantity of real power provided by ENCG was less than the directed amount. The asset did not meet the following requirements of section 205.6 of the ISO rules:

- 6(1) A pool participant must, within ten (10) minutes following receipt of a directive to provide supplemental reserve, ensure that its pool asset is providing a quantity of real power equal to the instantaneous amount of real power of the pool asset at the time of the directive and the amount of real power set out in the directive.
- (2) A pool participant must ensure that, from the first time its pool asset achieves the response set out in subsection 6(1) to the time 15 minutes following receipt of the directive, the pool asset is providing an average response greater than or equal to the amount of real power set out in the directive.

Based upon the information obtained by the MSA, the MSA is satisfied that the event was a contravention of section 205.6 of the ISO rules.

## NOTICE
