MSA FINDINGS

On March 9 and 10, 2024, during multiple settlement intervals, the HHW1 asset received multiple transmission constraint directives. The asset did not reduce its generation to the reliability limit that was in effect.

Section 301.2 of the ISO rules states, in part:

3(1) A market participant must comply with a directive it receives subject to any other ISO rule or reliability standard and the exceptions in subsections 3(2) and 3(3).

The MSA is satisfied that the conduct was a contravention of section 301.2 of the ISO rules.
