MSA FINDINGS			
On May 29, 2024, the KH3 asset received a dispatch to 0 MW with an effective time of 13:00. Shortly after 13:00, an operational deviation occurred which prevented the KH3 asset from ramping towards its dispatch level. At 13:59 the AESO System Controller was called to inform them that the KH3 asset was experiencing issues coming offline. Information available to the MSA indicates that KH3 did not reach its allowable dispatch variance until 22:47, and that an available capability or MW restatement was not made. Section 203.4 of the ISO rules states, in part: 5(1) A pool participant must, if a source asset experiences an operational deviation, verbally inform the ISO as soon as practicable of the occurrence of the operational deviation and provide a description of the cause if known. (2) A pool participant must inform the ISO of the information required under subsection 5(1) on a telephone line the ISO designates, which must contain a voice recording system. (3) A pool participant must, if an operational deviation extends for 20 minutes or longer, submit an available capability restatement or MW restatement for the source asset that represents the operational capability of the source asset and must do so no later than 20 minutes after the commencement of the operational deviation.			
The MSA is satisfied that the event was a contravention of ISO rule 203.4.
