### MSA FINDINGS

At 04:28 on February 9, 2025, URICA Energy Real Time Ltd. (URICA) received a directive from an AESO system controller for PAW1 to increase the voltage by 1kV at the Lanes Lake substation. At 04:35, URICA informed the system controller that PAW1 did not answer the phone and that they were unable to adjust the voltage. Section 301.2 of the ISO rules states, in part:

3(1) A market participant must comply with a directive it receives subject to any other ISO rule or reliability standard and the exceptions in subsections 3(2) and 3(3).

The MSA is satisfied that the event was a contravention of section 301.2 of the ISO rules.

### NOTICE

The Market Surveillance Administrator (MSA) is granted the power and authority under s. 52 of the *Alberta Utilities Commission Act* to issue a Notice of Specified Penalty where the MSA is satisfied that a person has contravened an ISO rule. Specified penalties are set out in AUC Rule 019.

In accordance with the relevant enactments and rules, a dispute regarding the issuance of a Notice of Specified Penalty or failure to pay the specified penalty in accordance with this notice will result in a hearing or other proceeding before the AUC.

In accordance with s. 5.1 of AUC Rule 019 this Notice of Specified Penalty will be made public no earlier than receipt of confirmation of payment from the Commission and no later than 45 days after issuance. The MSA will, if applicable, also post on its website the link to any decision of the AUC respecting the specified penalty.
