MSA FINDINGS

At 10:55, on October 22, 2024, for all hour endings (HE) of October 23, 2024, the minimum stable generation (MSG) for the FRM1 asset was restated from 0 MW to 266 MW. The 266 MW MSG was continuously declared until January 17, 2025, and then restated at 14:22 to 126 MW for the period of January 20 HE1 to January 21 HE24. Then, for all periods after until February 27, 2025, the MSG continued to be declared at 266 MW for each day. Information available to the MSA indicates that the MSG for the FRM1 asset should have been declared at 0 MW throughout the period.

Section 203.1 of the ISO Rules, states, in part:

(3) A pool participant must include in each operating block in an offer;

must also include in the offer the minimum stable generation for the source asset.

Where minimum stable generation is defined in the AESO's Consolidated Authoritative Document Glossary as, in part:

(i) the greater of the minimum generation level, in MW, that a source asset can be continuously operated at without: (a) becoming unstable: or

(b) violating environmental permits; [...]

The MSA is satisfied that the conduct was a contravention of section 203.1 of the ISO rules.
