MSA FINDINGS

On April 7, 2025, at approximately 16:05, the HAL1 asset received a transmission constraint directive effective at 16:07 to reduce real power. Between 16:07 and 17:05, the asset did not reduce its generation to the reliability limit that was in effect. Section 301.2 of the ISO rules states, in part:

3(1) A market participant must comply with a directive it receives subject to any other ISO rule or reliability standard and the exceptions in subsections 3(2) and 3(3).

The MSA is satisfied that the conduct was a contravention of section 301.2 of the ISO rules
