MSA FINDINGS					
Section 203.3 of the ISO rules states, in part:					
<p>(2) A pool participant that submits an offer must, if there is a change to the available capability of the source asset as a result of any of the circumstances outlined in subsections 2(1)(a), (b) or (c), submit an available capability restatement revising the available capability for the applicable hours, as soon as practicable.</p>					
On June 11, 2025, information available to the MSA indicates that the available capability ('AC') of the ERV1 asset was affected and an AC restatement was not submitted.					
The MSA is satisfied that the conduct was a contravention of section 203.3 of the ISO rules.

The Market Surveillance Administrator (MSA) is granted the power and authority under s. 52 of the <i>Alberta Utilities Commission Act</i> to issue a Notice of Specified Penalty where the MSA is satisfied that a person has contravened an ISO rule. Specified penalties are set out in AUC Rule 019.					
In accordance with the relevant enactments and rules, a dispute regarding the issuance of a Notice of Specified Penalty or failure to pay the specified penalty in accordance with this notice will result in a hearing or other proceeding before the AUC.
