MSA FINDINGS

On September 14, 2025, at approximately 16:46, the RYMD accepted a dispatch for 10 MW of regulating reserve effective for September 14, 2025, at 17:00. Information available to the MSA indicates that at the time that the dispatch became effective, the RYMD regulating reserve resource did not have its frequency support system enabled.

Section 205.4 of the ISO Rules states, in part:

6(1) while its pool participant must ensure that, while its pool asset is under dispatch to provide regulating reserve, the governor or governor system of each regulating reserve resource providing regulating reserve is operating such that:

(a) it is in service at all times;

The MSA is satisfied that the conduct was a contravention of Section 205.4 of the ISO rules.

NOTICE

The Market Surveillance Administrator (MSA) is granted the power and authority under s. 52 of the *Alberta Utilities Commission Act* to issue a Notice of Specified Penalty where the MSA is satisfied that a person has contravened an ISO rule. Specified penalties are set out in AUC Rule 019.

In accordance with the relevant enactments and rules, a dispute regarding the issuance of a Notice of Specified Penalty or failure to pay the specified penalty in accordance with this notice will result in a hearing or other proceeding before the AUC.

In accordance with s. 5.1 of AUC Rule 019 this Notice of Specified Penalty will be made public no earlier than receipt of confirmation of payment from the Commission and no later than 45 days after issuance. The MSA will, if applicable, also post on its website the link to any decision of the AUC respecting the specified penalty.
