## Requirement 1 of PER-006-AB-1 states:

Each operator of a generating unit or operator of an aggregated generating facility must provide training to personnel identified in the Applicability section on the operational functionality of protection systems and remedial action schemes that affect the output of a generating unit or an aggregated generating facility it operates.

**MSA FINDINGS** 

From July 1, 2023, to September 4, 2024, training on the operational functionality of protection systems and remedial action schemes that affect the output of a generating units it operates was not provided to personnel at Bear Creek, Mackay River and Redwater generating facilities.

As a result, the MSA is satisfied that TransCanada Energy Ltd. contravened requirement R1 of PER-006-AB-1 from July 1, 2023, to September 4, 2024.

## NOTICE
