## **MSA FINDINGS**

TA Alberta Hydro LP contravened R1 of PRC-025-AB-2 from October 1, 2024, to July 21, 2025, as the applied load-responsive relays settings associated with generating units Bighorn, Brazeau, Ghost, Rundle, and Spray were not in accordance with Appendix 3 – Relay Loadability Evaluation Criteria.

Requirement 1 of PRC-025-AB-2 states:

Each legal owner of a generating unit, legal owner of an aggregated generating facility, and legal owner of a transmission facility, must apply settings that are in accordance with Appendix 3 - Relay Loadability Evaluation Criteria to protection systems, excluding those listed in Appendix 2 – Excluded Protection Systems, on each load-response protection relay while maintaining reliable fault protection

The MSA is satisfied that the conduct was a contravention of Reliability Standard PRC-025-AB-2, requirement R1.

## NOTICE
